## Overview

I am a human molecular geneticist with an expertise in forensic serology and DNA. I have been a professor at California State University, Sacramento since 1998, where I developed and currently run an undergraduate education program in forensic biology.

I have reviewed DNA discovery in more than 100 criminal and civil cases since 2000, providing an independent assessment of DNA discovery and serving as an educator for attorneys, judges, and juries. I have produced reports or testified in court in most of these cases and stay current in the technologies utilized in the profession. I view consulting as an extension of my teaching: translating complex scientific ideas/concepts into clear, accessible language for non-experts.

I live and work in Sacramento, California but consult for attorneys throughout the United States and, occasionally, overseas. My primary focus is criminal defense and much of my work is with public defenders.
